THE ORIGIN OF FREEMASONRY

Often the question is asked: "Where and when did Freemasonry originate?"

In dealing with this question one must consider the standpoint from which it is to be answered. If one has in mind Freemasonry in its modern sense - that is, an organization divided into subordinate Lodges and operating under the authority of a Grand Lodge of a given jurisdiction and practicing the Rites of Symbolic Masonry such as, for instance, the United Grand Lodge of New South Wales of Ancient, Free and Accepted Masons. If this is what is meant, then it came into existence in London, England, in A.D.1717. (the present United Grand Lodge of New South Wales came into existence in 1888, when the four Grand Lodges then operating as separate entities within this State, viz., the English, the Irish, the Scottish and the Grand Lodge of New South Wales, of their own free will and accord, amalgamated and assumed the title of THE UNITED GRAND LODGE OF NEW SOUTH WALES OF ANCIENT, FREE AND ACCEPTED MASONS)

But Masonry in organized Lodges existed long before that time. The present-day Craft is in historical continuity with Lodges or Guilds of Masons who, centuries ago, engaged in the task of actual building and held meetings where the speculative feature of Masonry was also practiced at least to some extent. We may say that such Masonry came into existence in about the twelfth century A.D. It is true, however, that Masonry may be traced back even further than this period. If we refer to Masonry as applied to any secret society that makes use of or has made use of, some of the signs which we use (or symbols) then Masonry goes back several thousand years until it is lost in antiquity.

Current:

Article XI Scholarships

- Sec. 1. Two to five scholarships may be awarded each academic year (defined as the Fall and Spring Semesters). The number of scholarships awarded will be determined by a majority vote of the Lodge.
- Sec. 2. Each scholarship will be for One Thousand dollars and 00/100 (\$1,000.00) per applicant, for each academic year applied for and attended.
- Sec. 3. Each applicant shall be a High School graduate and enrolled in a college, university, community college or trade school. The applicant shall have graduated from high school with a 2.75 GPA or above. The application may be for undergraduate or graduate work. If undergraduate work, the applicant must have maintained a 2.75 GPA in an undergraduate school.
- Sec. 4. The Masonic Scholarship Committee (MSC) appointed by the Worshipful Master will provide and review the applications of all first time applicants, conduct interview(s) and/or do further investigation with respect to applicants. Applicants will be required to provide their social security number, and to authorize the MSC to obtain such credit reports, and to make such investigations, as it deems appropriate.
- Sec. 5. The MSC will base their decisions on:
 - a. Priority given to relatives of Tennessee Master
 - b. Financial need
 - c. Performance
 - d. Curriculum
- Sec. 6. Renewal is not assured, and will require re-application each academic year. A copy of the transcript of applicant's grades is required for consideration or renewal, and should be provided by the applicant.
- Sec. 7. The scholarship will be dispersed at the rate of One thousand dollars and 00/100 (\$1,000.00), per academic year; payable to his/her account at the school they are attending. The funds may be used tuition, books, supplies and other such educationally related expenses. Any unused funds will be returned to the MSC.

Proposed:

Article XI Scholarships

- Sec. 1. Up to five scholarships may be awarded each academic year (defined as the Fall and Spring Semesters). The number of scholarships awarded will be determined by the Masonic Scholarship Committee (MSC) based on the funds made available by vote of the Lodge.
- Sec. 2. Each scholarship amount per applicant, for each academic year applied for and attended, will be determined by the MSC based on the funds available.
- Sec. 3. Each applicant shall be a High School graduate and enrolled in a college, university or community college. The applicant shall have graduated from high school with a 3.0 GPA or above. The application may be for undergraduate or graduate work. If undergraduate work, the applicant must have maintained a 3.0 GPA in an undergraduate school.
- Sec. 4. Each applicant for a trade or vocational school scholarship shall be a High School graduate and enrolled in a trade or vocational school. The applicant shall have graduated from high school with a 2.0 GPA or above.
- Sec. 5. The Masonic Scholarship Committee (MSC) appointed by the Worshipful Master will provide and review the applications of all first time applicants, conduct interview(s) and/or do further investigation with respect to applicants.
- Sec. 6. The MSC will base their decisions on:
 - a. Priority given to relatives of Tennessee Master Masons
 - b. Performance
 - c. Curriculum
- Sec. 7. Renewal is not assured, and will require re-application each academic year. A copy of the transcript of applicant's grades is required for consideration or renewal, and should be provided by the applicant.
- Sec. 8. The scholarship will be dispersed per academic year; payable to his/her account at the school they are attending. The funds may be used tuition, books, supplies and other such educationally related expenses. Any unused funds will be returned to the MSC.
